Fees Are Due Once Again!

Production Fees

Production fees for seed harvested from all crops are due within 30 days after harvest. Fees for the 2007 cropping season must be received by April 15, 2008. **Fees are due on all crops which have passed the field inspection even if they do not pass final lab analysis or are not carried through certification beyond field inspection.**

Growers may not receive an invoice for crops grown under contract with a seed dealer. All fees should be calculated on a clean seed basis. To determine "clean seed" production on an uncleaned lot, deduct 10% (average cleanout) from total uncleaned production.

Prices are as follows:

Barley-Oats-Buckwheat-Peas-Lentils	.08/cwt on clean seed
Oil Seeds	.12/cwt on clean seed
Perennial Crops—	
All Grass Varieties	.005/lb
Perennial Legume Crops	.005/lb
Flowering Saltbush	.25/cwt
Field Beans—No production fees are due on bean seed production.

SECAN Royalty Payments

Notices will be sent out to contractors and growers of Harrington and AC Metcalfe barley requesting payment of royalty fees for SECAN varieties sold between July 1, 2006 and June 30, 2007. The fee is 24 cents per bushel sold for Harrington barley and 51 cents per bushel for AC Metcalfe barley (for AC Metcalfe, fees are also due on seed a grower keeps and plants on his own land). If you have Harrington or AC Metcalfe seed from an earlier year which was sold for planting in the spring of 2007, the same rates apply and are due to MSGA. Please pay these fees promptly to ensure the continued availability of Harrington and AC Metcalfe barley seed. Royalty fees for the crop produced in the 2007 crop season will be **due in September of 2008.** Please contact the office if you have questions on what you owe. Next year's fees are not yet available, but SECAN has advised us they will most likely be going up. MSGA will have those figures available within the next couple weeks.

MSU Seed Specialists Speak

Recently Ron Larson of MSGA and Bill Grey of MSU Foundation Seeds traveled to Miles City to speak at the Montana Extension Agent Conference. The topic – Certified Seed. Joe Broesder, the Hill County Extension Agent, began the session by discussing the Hill County Drill Box Survey. This survey included data from 2004-2006 comparing certified seed vs. common seed planted in Hill



County. Ron followed this presentation with discussion of the seed certification process, the role of MSGA, the importance of proper labeling for seed, an overview of seed law, and Plant Variety Protection (PVP). Bill finished the session with a discussion about variety sources and how certified seed works for the producer in management of the Wheat stem sawfly. His topic also included discussion of solid stem characteris-

tics, wheat breeding goals, and producer acceptance of certified seed and MSU protected varieties. *If you would like more information on these topics please contact the MSGA office.*

MSGA DIRECTOR ELECTIONS

It is time again for elections for MSGA board members. This year, elections will be conducted for Director for Experiment Station District 4, currently held by Jim Kulish of Stanford, and comprised of Cascade, Judith Basin, Fergus, Petroleum, Musselshell, Golden Valley, and Wheatland counties; and District 6, currently held by Bear Whitmer of Bloomfield, and comprised of Valley, Daniels, Sheridan, Roosevelt, Garfield, McCone, Richland, Dawson, Prairie, and Wibaux counties.

All growers enrolled in the program in District 4 and 6 for the 2007 growing season are eligible to vote, and any grower living within the two districts who has been a member grower of MSGA for the last three years (as shown by the signing of an Application for Certification) may be elected to serve as a director. The term of office for each director is three years. Primary election ballots are on their way! The three candidates with the most votes in the primary election will then move on to the general election.

MSGA will have a booth at the Montana Grain Growers Association Convention and the MATE Show so please stop by and say hello!

2007 Crop Summary

The 2007 crop season progressed very quickly this summer due to warm, extremely dry conditions over most of the state. In many areas, inspections were required up to 3 weeks ahead of last year. Dryland growers reported good yields generally on winter wheat, but most spring crops suffered from the dry conditions, resulting in generally low yields. Preliminary information from alfalfa growers indicate some good yields in that crop as well.

This year the certification program was close to the record 2005 applied acreage, at 59,027 acres. We had fewer total applicants but

number of acres per application increased significantly. Total acres applied for as spring wheat decreased again this year and winter wheat acres increased. Current seasonal growing conditions and moisture patterns seemed to be favoring fall seeded crops.

Is Your Head Spinning From Watching the Wheat Prices? By Bill Grey

“The high demand for seed also caused a shortage of certified winter wheat seed, including Genou.”

Who would have predicted the boom in wheat prices! Well, this market has definitely caused a huge shortage of winter wheat seed this fall as producers are in the “furrow” to plant a record number of acres. The table below shows foundation sales of recent MSU varieties that are PVP title V and with a research fee. The high demand for seed also caused a shortage of certified winter wheat seed, including Genou. The pattern of foundation sales for Genou may

provide a clue as to why we were so short this fall. For the 2006 seed crop year, there were only 250 acres of registered seed enrolled with MSGA. When the low acreage is compounded with low purchases of foundation seed in 2006 (378bu) and 2007 (170bu), the stage is set for a shortage of certified seed when demand is high. What’s the magic number of registered acres to enroll and certified seed to carry as inventory? That’s where the opportunity lies for seed producers, just in case of.....high wheat prices!

CHECK-OFF SHEET FOR SEED LABELERS requesting INTERAGENCY TAGS

For those members/dealers buying seed from an out-of state source, the 3 steps listed below will help facilitate efficiency of processing and delivery of tags or bulk certificates.

1. Labeler must supply the Seed Certifying Agency (MSGA) a copy of the Inter-State Shipping (or “Ship-for-Process”) Permit, as issued by the originating State Seed Certifying Agency. The seed producer or originating seed dealer should supply this document with the lot of seed as it is trucked out. This is seed certifying agency documentation that the lot has passed field inspection in the originating state or province and shows the amount that is being shipped.

OR

A copy of the completed field inspection form showing that the field passed inspection.

2. If seed has been tested in a seed lab other than the Montana State Seed Lab., the labeler (tag requestor) must submit the lab analysis report to the certifying agency which is supplying the tags or bulk seed sale certificates. The analysis on the report must meet MSGA Standards.
3. Seed originating in Canada should be re-tested in order to be properly labeled and insure it meets MSGA standards.

WARNING: Selling Common Seed of PVP Title 5 Protected Varieties is Illegal

Recent reports of potential PVP violations have prompted us to remind our producers that selling of PVP Title 5 protected varieties, whether private or public, for seed is not legal unless they have been certified by MSGA or a certifying agency from another state. While we do not have control over illegal seed sales by non-MSGA members, we can remind you, our members, to obey the law and avoid selling common seed of these varieties, as per the PVP law. Most people do not like turning in their neighbors for such violations, so please do all you can to educate your customers and neighbors with regard to the restrictions on seed sales of these varieties. MSGA has indicated which varieties are protected in the grower directory. Included with this newsletter is a list of the varieties that currently have PVP protection.

Montana Plant Variety Protection 'Working List'.

The Montana PVP Working List contains varieties with PVPA title V, or PVPA and enrolled in the Montana Seed Certification Program. October 15, 2007.

Plant breeders, seed and crop producers are partners. They depend on each other. This partnership is defined by the Plant Variety Protection Act of 1970 (PVP), which offers legal protection in commerce for plant varieties reproduced by seed.

Recent U.S. Supreme Court and District Court rulings and 1994 Amendments to PVP state that:

A farmer may increase and save seed of a new PVP variety to plant on his own farm. He cannot sell any saved seed without express permission from the variety owner. Also, if it was PVP title V protected, the seed must be sold as a class of certified seed.

A seed processor is potentially liable if he cleans seed for another party who sells unauthorized seed.

The variety owner can recover damage relating to unauthorized seed sales as well as crop production resulting from those sales.

Labeling of seed is irrelevant in determining liability. The rules cannot be circumvented by marketing a PVP variety as "variety not stated" (VNS) or "grain", or buying grain or feed and converting it to planting purposes.
